Item 7000 and Option Items 7100, 7200, 7300, and 7400 - The Contractor shall provide SERVICES in accordance with Section C - Statement of Work (SOW) below.

Item 9000 and Option Items 9100, 9200, 9300, and 9400 - The Contractor shall provide ODCs in support of CLINS 7000, 7100, 7200, 7300, and 7400 in accordance with the SOW below.

Item 7001 and Option Items 7101, 7201, 7301, and 7401 - The Contractor shall provide DATA as specified in Exhibit A- Contract Data Requirements List for CDRLs A001-A002 as required in the SOW below.

STATEMENT OF WORK

NAWCAD COMPTROLLER FINANCIAL SERVICES

1.0 INTRODUCTION

1.1 The Comptroller Department and the Program and Business Analysis Department are known as the Business and Financial Management Community (BFMC) and provide business and financial services and products that improve performance, quality, timeliness and efficiency throughout the organization, including the Naval Air Warfare Center Aircraft Division (NAWCAD) and the Naval Air System Command (NAVAIR). The Comptroller Department also provides liaison support with the NAVAIR Enterprise Resource Planning (ERP) Business Office (PMA203) and the Navy ERP Program Office (PEO-EIS).

2.0 SCOPE

2.1 This task order will serve as the primary contractual agreement to provide support services to the NAWCAD Accounting Department (AD 10.2). The contractor shall support the Comptroller in maintaining daily operations. These services shall include administrative functions, data entry accounting processes, interface error research and analysis, process management, deficiency identification, testing of system changes, professional and analytical support, and liaison support with the NAVAIR ERP Business Office (PMA203) and Navy ERP Program Office (PEO-EIS). The NAWCAD Accounting Department performs services for NAVAIR Headquarters. These services primarily involve internally entitled invoices as discussed in Section 4.2 below. The contractor shall possess an in-depth understanding of Navy Working Capital Funds and a working knowledge of General Funds.

3.0 APPLICABLE DOCUMENTS

3.1 All relevant Department of Defense (DOD) and Financial Management Regulations (FMR) instructions, Financial Improvement Audit Readiness Control Points (FIAR), any pertinent NAVAIR and NAWCAD policies, procedures and guidelines, as well as any internal

Comptroller policies, procedures, and guidelines necessary to complete tasking. Additionally, specific Navy Supply (NAVSUP) guidelines as found in NAVSUP P-485 V1-3 Afloat Supply Procedures and NAVSUP P-409 MILSTRIP/MILSTRAP Desk Guide.

4.0 TECHNICAL REQUIREMENTS

4.1 The contractor shall provide specialized reviews and analysis to support the continued evolution of DON Financial Improvement and Audit Readiness (FIAR) efforts. This includes standardized procedures, financial data analysis and system analysis of Navy ERP to ensure data integrity, financial stability, and timely reporting for NAWC business requirements. Contractor support personnel shall have strong interpersonal and communication skills, as they are required to interface with all levels at NAVAIR as well as external Commands. Extensive working knowledge in the following ERP modules is required: Sales and Distribution (SD), Material Management (MM), Financial (FI), and Funds Management (FM). Familiarity with the following ERP modules is beneficial: Asset Management (AM), Controlling (CO), and Project Systems (PS).

4.1.1 The contractor shall perform research and analysis by utilizing the ERP Internal Tables to extract information from the official financial system where: (1) no standardized reports exist; (2) additional information for standardized reports is required; and (3) to support reconciliation efforts.

4.1.2 The contractor shall provide analytical support to complete data calls from the Navy/Department of Defense Comptroller and other activities with diversified missions and requirements, including data calls at both the field activity level and headquarters level. This support includes recommendations for extracting the information from the financial system through either standardized transactions or ADHOC queries from ERP internal tables.

4.1.3 The contractor shall provide support in the analysis and completion of the following: Management Control reviews (MCR), Internal audit checks, gap analysis, Control Point impacts, Corrective Action Plan reviews, and Navy ERP Change Requests.

4.2 The contractor shall provide support for the Cost Accounting Department (AD 10.2.4). Extensive working knowledge is required for the following systems: Cash History On-line Operator Search Engine (CHOOSE), Shared Data Warehouse (SDW), and Mechanization of Contracts Administration Services (MOCAS). Working knowledge of the following systems is required: Standard Procurement System (SPS), Seaport, and Electronic Document Access (EDA). In the MILSTRIP area, familiarity with the Supply system interface is beneficial, including: Transactions Online Processing System (TOPS) and Naval Aviation Logistics Command Management Information System (NALCOMIS). Access to the following websites will be required: WEBVLIPS, One Touch, GSA, and EMALL.

4.2.1 The contractor shall provide support for the Internal Entitlement team in the areas of: processing hard copy invoices from vendors, processing electronic invoices from Wide Area Workflow (WAWF) to the Navy ERP system, validating invoices for correctness, obtaining the appropriate receipt and acceptance, and closing out contracts. Working knowledge of the

entitlement process is required. Familiarity with WAWF and the NAWCAD Comptroller Document Management System (CDMS) is beneficial.

4.2.2 The contractor shall support the MILSTRIP team in researching/analyzing and resolving interface errors, researching/resolving various billing issues with billing activities, and goods receipt research and follow-up.

4.2.3 The contractor shall support the Outgoing Funding Document team in commitment follow-up, processing obligating documents, accruals, encumbrance reviews and audits.

4.2.4 The contractor shall support the Travel Accounting Team in travel related accounting transactions, which would include, but is not limited to, uploading travel voucher documents to the Transactions Online Processing System (TOPS), reconciling Accounts Payable balances, researching open commitment and obligation records, and researching unmatched disbursement records and travel transactions rejected by Navy ERP. Familiarity with the travel process and the Defense Travel System (DTS) is beneficial.

4.3 The contractor shall provide support for the General Ledger Accounting Department (AD 10.2.3). Familiarity with the following systems is beneficial: Defense Integrated Financial System (DIF) and Cash History On-line Operator Search Engine (CHOOSE).

4.3.1 The contractor shall provide support for fixed asset accounting in the following areas: perform physical inventory of assets, provide inventory information to Inventory Lead to ensure accurate accountability of fixed assets for property management purposes, and obtain supporting documentation for the creation/modification/retirement of asset records and sub asset records in Navy ERP.

4.3.2 The contractor shall provide support in the area of performing reimbursable billing and in finalizing reimbursable funding documents. This includes the research and identification of outstanding encumbrances as well as identifying excess funds.

4.3.3 The contractor shall provide support in the area of the government purchase card, including: review of open commitments, open obligations, missing and over-aged goods receipts, and aged invoices.

4.4 The contractor shall provide administrative support to the various teams within the Accounting Department.

4.4.1 The contractor shall support the Cost Accounting Department in scanning various documents into CDMS and/or Navy ERP, downloading data from external systems for contracts and invoices, maintaining filing systems for various documents, and distributing data and documentation as required.

4.4.2 The contractor shall provide support to the Fixed Asset team including data entry in Navy ERP, scanning back-up documentation into Navy ERP, and maintaining filing systems for asset records.

4.4.3 The contractor shall support the General Ledger Department in the preparation of documentation for miscellaneous collections, maintain adjustment logs, scan documentation into CDMS and/or Navy ERP, and maintain filing systems as appropriate.

5.0 DELIVERABLES

5.1 CDRL Item A001 – Incurred Cost and Progress Reporting. In order to support invoice reviews conducted as part of proper surveillance, the contractor shall report incurred cost and progress in accordance with NAVAIR clause 5252.232-9529, “Incurred Cost and Progress Reporting for Services,” CDRL A001, and Attachment 3.

5.2 CDRL Item A002 – Contractor Progress, Status, and Management Report. Refer to CDRL for specific requirements.

6.0 OTHER DIRECT COSTS

6.1 Local travel may be required during the performance of this effort, as directed by the Accounting Officer, NAWCAD 10.2. Local travel includes day trips from Patuxent River, MD to Annapolis, MD or Washington DC. Travel must be approved by the COR prior to departure.

6.2 Travel costs incurred by the contractor shall be reimbursed in accordance with NAVAIR clause 5252.232-9509, “Reimbursement of Travel, Per Diem, and Special Material Costs,” and Seaport-e provision HQ B-2-0020, “Travel Costs – Alternate I (NAVSEA).”

7.0 PERFORMANCE REQUIREMENTS

7.1 Performance Requirements. See Surveillance Activity Checklist (SAC), Attachment 1.

7.2 Place of Performance. The services identified within this contract shall be performed at Government site at Patuxent River, MD.

8.0 SECURITY CONSIDERATIONS

8.1 All contractor personnel will have access to information that may be subject to the Privacy Act. The contractor is required to ensure the proper safeguarding of such information to prevent unauthorized release. Only United States citizens may perform under this contract. The contractor shall conform to the provisions of DOD-D-5220.22, ‘National Industrial Security Program’, and shall obtain security clearances for contractor employees requiring access to classified information and/or entry to controlled areas. All tasking under this effort will be unclassified. Any person having had a security clearance revoked for any reason shall be ineligible to perform under this order. All contractor personnel supporting tasks under this order must be able to obtain a Secret security clearance, should it become necessary. A background check may be required for access to certain systems and applications.

8.2 Site Access Requirements: The contractor shall comply with specific site access requirements.

8.3 The contractor shall comply with Navy security regulations. All persons engaged in work while on Government property shall be subject to search of their person and vehicles at any time by the Government and shall report any known or suspected security violations to the Security Department. The contractor shall remove from contract performance any person who endangers life, property, or national security through improper conduct.

8.4 Contractor identification badges shall be issued by the Government to contractor personnel requiring access to the installation and shall be visible at all times while contractor employees are on the Government facility. The contractor shall furnish all requested information required to facilitate issuance of identification badges and shall conform to applicable regulations concerning the use and possession of the badges. The contractor shall be responsible for ensuring that all identification badges issued to contractor employees are returned to the Security Department within forty-eight hours following completion of contract, relocation, or termination of an employee, and upon request of the Procuring Contracting Officer or the Contracting Officer's Representative.

9.0 WORK SCHEDULE

9.1 The following is a list of Federal Government holidays. Individual Contractor employees are encouraged to work in accordance with the same schedules as the Government office they support. However, it is solely at the Contractor's discretion which Federal and State holidays they choose to observe.

9.2 The contractor shall provide the required services and staffing coverage during normal working hours. Normal working hours are usually 8.5 hours (including a 30-minute lunch), from 0730-1600 each Monday through Friday (except on Government holidays). Some supported Government offices have the flexibility to start as early as 0600 and end as late as 1800 Monday through Friday. Services and staffing shall be provided at least 8 hours per day (during the 8.5 hour workday which includes the 30-minute lunch). Contractor work schedules shall be coordinated with the COR to ensure coverage during critical periods, coordination of tasks involving other contractors, coordination of coverage for tasking, and security compliance for buildings/area where access is controlled.

9.3 Compressed Work Schedule (CWS) is an alternative work schedule to the traditional five 8.5 hour workdays (which includes a 30-minute lunch) worked per week. Under a CWS schedule an employee completes the following schedule within a two-week time period: eight weekdays are worked at 9.5 hours each (which includes a 30-minute lunch), one weekday is alternately worked at 8.5 hours (which includes a 30-minute lunch), and one weekday is not worked by the employee. The result is 80 hours worked every two weeks, with 44 work hours one week and 36 work hours the other.

9.4 The contractor awarded this contract, with prior agreement by the COR, may allow its employees to work a CWS schedule. Any contractor that chooses to allow its employees to work a CWS schedule in support of this contract agrees that any additional costs associated with the implementation of the CWS schedule vice the standard schedule are unallowable under this contract and will not be reimbursed by the Government. Additionally, the CWS schedule shall not prevent the contractor from providing the necessary staffing and services coverage when required by the Government. If agreement to implement the CWS schedule is reached with the COR, the overall schedule must be provided and approved. Key contractor personnel, at the discretion of the COR, may not be allowed to work a CWS schedule even if the remaining employees are permitted to do so. The intent is to provide needed coverage for work while allowing a benefit to accrue to affected employees.

10.0 GOVERNMENT FURNISHED PROPERTY (GFP) / GOVERNMENT FURNISHED EQUIPMENT (GFE)

10.1 The following government furnished property may be provided to, and utilized by, the contractor in relation to its performance under this contract:

- a. Office equipment, storage and ancillary working space for contractor personnel working on-site;
- b. Access to government offices and facilities as required to complete assigned tasks;
- c. Use of government telephones for conducting official government business;
- d. Desks, chairs, printers and personal computers.
- e. NMCI computers.

11.0 IDENTIFICATION BADGES AND CONTRACTOR ACCESS

11.1 To gain access to the NAS Patuxent River Complex, including Webster Field and NRC Solomons, contractors will need a Common Access Card (CAC), a RAPID Gate card, or a temporary paper pass issued from the Pass Office. Proof of U.S. citizenship is required to obtain a proper badge and to be permitted to access the government installations. 11.2 The Government will provide the contractor access to Government facilities, as required, for performance of tasks under this SOW.

11.3 Contractor personnel arriving without prior visit approval will not be processed until the visit has been entered and approved in BASICS II by the COR. A base access locator form must be submitted 72 hours before the visit to the COR. Appropriate identification media will then be issued. Permanently assigned full-time contractor support personnel, as identified by visit requests, will be issued a photographic ID badge or the appropriate passes for the duration of the contract or one year, whichever is shorter.

- (2) a description of the work to be performed;
- (3) the dollar amount;
- (4) the period of performance; and
- (5) a description of the contractor's internal controls and planned actions, to avoid any potential organizational conflict of interest.

not permissible means of communicating technical direction during contract performance.

(12) “Government purpose” means any activity in which the United States Government is a party, including cooperative agreements with international or multi-national defense organizations, or sales or transfers by the United States Government to foreign governments or international organizations. Government purposes include competitive procurement, but do not include the rights to use, modify, reproduce, release, perform, display, or disclose technical data for commercial purposes or authorize others to do so.

(13) “Government purpose rights” means the rights to--

(i) Use, modify, reproduce, release, perform, display, or disclose technical data within the Government without restriction; and

(ii) Release or disclose technical data outside the Government and authorize persons to whom release or disclosure has been made to use, modify, reproduce, release, perform, display, or disclose that data for United States government purposes.

(14) “Limited rights” means the rights to use, modify, reproduce, release, perform, display, or disclose technical data, in whole or in part, within the Government. The Government may not, without the written permission of the party asserting limited rights, release or disclose the technical data outside the Government, use the technical data for manufacture, or authorize the technical data to be used by another party, except that the

Government may reproduce, release, or disclose such data or authorize the use or reproduction of the data by persons outside the Government if--

(i) The reproduction, release, disclosure, or use is--

(A) Necessary for emergency repair and overhaul; or

(B) A release or disclosure to--

(1) A covered Government support contractor, for use, modification, reproduction, performance, display, or release or disclosure to authorized person(s) in performance of a Government contract; or

(2) A foreign government, of technical data other than detailed manufacturing or process data, when use of such data by the foreign government is in the interest of the Government and is required for evaluational or informational purposes;

(ii) The recipient of the technical data is subject to a prohibition on the further reproduction, release, disclosure, or use of the technical data; and

(iii) The contractor or subcontractor asserting the restriction is notified of such reproduction, release, disclosure, or use.

(15) "Technical data" means recorded information, regardless of the form or method of the recording, of a scientific or technical nature (including computer software documentation). The term does not include computer software or data incidental to contract administration, such as financial and/or management information.

(16) "Unlimited rights" means rights to use, modify, reproduce, perform, display, release, or disclose technical data in whole or in part, in any manner, and for any purpose whatsoever, and to have or authorize others to do so.

(b) *Rights in technical data.* The Contractor grants or shall obtain for the Government the following royalty free, world-wide, nonexclusive, irrevocable license rights in technical data other than computer software documentation (see the Rights in Noncommercial Computer Software and Noncommercial Computer Software Documentation clause of this contract for rights in computer software documentation):

(1) Unlimited rights. The Government shall have unlimited rights in technical data that are--

(i) Data pertaining to an item, component, or process which has been or will be developed exclusively with Government funds;

(vii) Otherwise publicly available or have been released or disclosed by the Contractor or subcontractor without restrictions on further use, release or disclosure, other than a release or disclosure resulting from the sale, transfer, or other assignment of interest in the technical data to another party or the sale or transfer of some or all of a business entity or its assets to another party;

(viii) Data in which the Government has obtained unlimited rights under another Government contract or as a result of negotiations; or

(ix) Data furnished to the Government, under this or any other Government contract or subcontract there

(A) Government purpose license rights or limited rights and the restrictive condition(s) has/have expired;
or

(2) Government purpose rights.

(i) The Government shall have government purpose rights for a five-year period, or such other period as may be negotiated, in technical data--

(A) That pertain to items, components, or processes developed with mixed funding except when the Government is entitled to unlimited rights in such data as provided in paragraphs (b)(1)(ii) and (b)(1)(iv) through (b)(1)(ix) of this clause; or

(B) Created with mixed funding in the performance of a contract that does not require the development, manufacture, construction, or production of items, components, or processes.

(B) The recipient is a Government contractor receiving access to the data for performance of a Government contract that contains the clause at DFARS 252.227-7025, Limitations on the Use or Disclosure of Government-Furnished Information Marked with Restrictive Legends.

(iv) The Contractor has the exclusive right, including the right to license others, to use technical data in which the Government has obtained government purpose rights under this contract for any commercial purpose during the time period specified in the government purpose rights legend prescribed in paragraph (f)(2) of this clause.

(3) Limited rights.

The standard license rights granted to the Government under paragraphs (b)(1) through (b)(3) of this clause, including the period during which the Government shall have government purpose rights in technical data, may be modified by mutual agreement to provide such rights as the parties consider appropriate but shall not provide the Government lesser rights than are enumerated in paragraph (a)(14) of this clause. Any rights so negotiated shall be identified in a license agreement made part of this contract.

(5) Prior government rights. Technical data that will be delivered, furnished, or otherwise provided to the Government under this contract, in which the Government has previously obtained rights shall be delivered, furnished, or provided with the pre-existing rights, unless--

(i) The parties have agreed otherwise; or

design details, algorithms, processes, flow charts, formulae, and related material that would enable the software to be reproduced, recreated, or recompiled. Computer software does not include computer databases or computer software documentation.

(5) "Computer software documentation" means owner's manuals, user's manuals, installation instructions, operating instructions, and other similar items, regardless of storage medium, that explain the capabilities of the computer software or provide instructions for using the software.

(6) "Covered Government support contractor" means a contractor under a contract, the primary purpose of which is to furnish independent and impartial advice or technical assistance directly to the Government in support of the Government's management and oversight of a program or effort (rather than to directly furnish an end item or service to accomplish a program or effort), provided that the contractor--

(i) Is not affiliated with the prime contractor or a first-tier subcontractor on the program or effort, or with any direct competitor of such prime contractor or any such first-tier subcontractor in furnishing end items or services of the type developed or produced on the program or effort; and

(ii) Receives access to technical data or computer software for performance of a Government contract that contains the clause at 252.227-7025, Limitations on the Use or Disclosure of Government-Furnished Information Marked with Restrictive Legends.

(7) "Developed" means that--

(i) A computer program has been successfully operated in a computer and tested to the extent sufficient to demonstrate to reasonable persons skilled in the art that the program can reasonably be expected to perform its intended purpose;

(ii) Computer software, other than computer programs, has been tested or analyzed to the extent sufficient to demonstrate to reasonable persons skilled in the art that the software can reasonably be expected to perform its intended purpose; or

(iii) Computer software documentation required to be delivered under a contract has been written, in any medium, in sufficient detail to comply with requirements under that contract.

(8) "Developed exclusively at private expense" means development was accomplished entirely with costs charged to indirect cost pools, costs not allocated to a government contract, or any combination thereof.

(i) Private expense determinations should be made at the lowest practicable level.

(ii) Under fixed-price contracts, when total costs are greater than the firm-fixed-price or ceiling price of the contract, the additional development costs necessary to complete development shall not be considered when determining whether development was at government, private, or mixed expense.

(9) "Developed exclusively with government funds" means development was not accomplished exclusively or partially at private expense.

(10) "Developed with mixed funding" means development was accomplished partially with costs charged to indirect cost pools and/or costs not allocated to a government contract, and partially with costs charged directly to a government contract.

(11) "Government purpose" means any activity in which the United States Government is a party, including cooperative agreements with international or multi-national defense organizations or sales or transfers by the United States Government to foreign governments or international organizations. Government purposes include competitive procurement, but do not include the rights to use, modify, reproduce, release, perform, display, or disclose computer software or computer software documentation for commercial purposes or authorize others to do so.

(12) "Government purpose rights" means the rights to--

(i) Use, modify, reproduce, release, perform, display, or disclose computer software or computer software documentation within the Government without restriction; and

(13) "Minor modification" means a modification that does not significantly alter the nongovernmental function or purpose of the software or is of the type customarily provided in the commercial marketplace.

(14) "Noncommercial computer software" means software that does not qualify as commercial computer software under paragraph (a)(1) of this clause.

(15) "Restricted rights" apply only to noncommercial computer software and mean the Government's rights to-

(i) Use a computer program with one computer at one time. The program may not be accessed by more than one terminal or central processing unit or time shared unless otherwise permitted by this contract;

(ii) Transfer a computer program to another Government agency without the further permission of the Contractor if the transferor destroys all copies of the program and related computer software documentation in its possession and notifies the licensor of the transfer. Transferred programs remain subject to the provisions of this clause;

(iii) Make the minimum number of copies of the computer software required for safekeeping (archive), backup, or modification purposes;

(iv) Modify computer software provided that the Government may--

(A) Use the modified software only as provided in paragraphs (a)(15)(i) and (iii) of this clause; and

(B) Not release or disclose the modified software except as provided in paragraphs (a)(15)(ii), (v), (vi), and (vii) of this clause;

(B) Such contractors or subcontractors are subject to the use and non-disclosure agreement at 227.7103-7 of the Defense Federal Acquisition Regulation Supplement (DFARS) or are Government contractors receiving access to the software for performance of a Government contract that contains the clause at DFARS 252.227-7025, Limitations on the Use or Disclosure of Government-Furnished Information Marked with Restrictive Legends;

(C) The Government shall not permit the recipient to decompile, disassemble, or reverse engineer the software, or use software decompiled, disassembled, or reverse engineered by the Government pursuant to paragraph (a)(15)(iv) of this clause, for any other purpose; and

(D) Such use is subject to the limitation in paragraph (a)(15)(i) of this clause;

(vi) Permit contractors or subcontractors performing emergency repairs or overhaul of items or components of items procured under this or a related contract to use the computer software when necessary to perform the repairs or overhaul, or to modify the computer software to reflect the repairs or overhaul made, provided that--

(A) The intended recipient is subject to the use and non-disclosure agreement at DFARS 227.7103-7 or is a Government contractor receiving access to the software for performance of a Government contract that contains the clause at DFARS 252.227-7025, Limitations on the Use or Disclosure of Government-Furnished Information Marked with Restrictive Legends; and

(B) The Government shall not permit the recipient to decompile, disassemble, or reverse engineer the software, or use software decompiled, disassembled, or reverse engineered by the Government pursuant to paragraph (a)(15)(iv) of this clause, for any other purpose; and

(vii) Permit covered Government support contractors to use, modify, reproduce, perform, display, or release or disclose the computer software to authorized person(s) in the performance of Government contracts that contain the clause at 252.227-7025, Limitations on the Use or Disclosure of Government-Furnished Information Marked with Restrictive Legends.

(16) "Unlimited rights" means rights to use, modify, reproduce, release, perform, display, or disclose computer software or computer software documentation in whole or in part, in any manner and for any purpose whatsoever, and to have or authorize others to do so.

(b) *Rights in computer software or computer software documentation.* The Contractor grants or shall obtain for the Government the following royalty free, world-wide, nonexclusive, irrevocable license rights in noncommercial computer software or computer software documentation. All rights not granted to the Government are retained by the Contractor.

(1) Unlimited rights. The Government shall have unlimited rights in--

(i) Computer software developed exclusively with Government funds;

(ii) Computer software documentation required to be delivered under this contract;

(iii) Corrections or changes to computer software or computer software documentation furnished to the Contractor by the Government;

(iv) Computer software or computer software documentation that is otherwise publicly available or has been released or disclosed by the Contractor or subcontractor without restriction on further use, release or disclosure, other than a release or disclosure resulting from the sale, transfer, or other assignment of interest in the software to another party or the sale or transfer of some or all of a business entity or its assets to another party;

(v) Computer software or computer software documentation obtained with unlimited rights under another Government contract or as a result of negotiations; or

(vi) Computer software or computer software documentation furnished to the Government, under this or any other Government contract or subcontract there under with--

(A) Restricted rights in computer software, limited rights in technical data, or government purpose license rights and the restrictive conditions have expired; or

(B) Government purpose rights and the Contractor's exclusive right to use such software or documentation for commercial purposes has expired.

(2) Government purpose rights.

(i) Except as provided in paragraph (b)(1) of this clause, the Government shall have government purpose rights in computer software development with mixed funding.

(ii) Government purpose rights shall remain in effect for a period of five years unless a different period has been negotiated. Upon expiration of the five-year or other negotiated period, the Government shall have unlimited rights in the computer software or computer software documentation. The government purpose rights period shall commence upon execution of the contract, subcontract, letter contract (or similar contractual instrument), contract modification, or option exercise that required development of the computer software.

(iii) The Government shall not release or disclose computer software in which it has government purpose rights to any other person unless--

(A) Prior to release or disclosure, the intended recipient is subject to the use and non-disclosure agreement at DFARS 227.7103-7; or

(B) The recipient is a Government contractor receiving access to the software or documentation for performance of a Government contract that contains the clause at DFARS 252.227-7025, Limitations on the Use or Disclosure of Government Furnished Information Marked with Restrictive Legends.

(3) Restricted rights.

(i) The Government shall have restricted rights in noncommercial computer software required to be delivered or otherwise provided to the Government under this contract that were developed exclusively at private expense.

(5) Prior government rights. Computer software or computer software documentation that will be delivered, furnished, or otherwise provided to the Government under this contract, in which the Government has previously obtained rights shall be delivered, furnished, or provided with the pre-existing rights, unless--

(i) The parties have agreed otherwise; or

(ii) Any restrictions on the Government's rights to use, modify, reproduce, release, perform, display, or disclose the data have expired or no longer apply.

(6) Release from liability. The Contractor agrees to release the Government from liability for any release or disclosure of computer software made in accordance with paragraph (a)(15) or (b)(2)(iii) of this clause, in accordance with the terms of a license negotiated under paragraph (b)(4) of this clause, or by others to whom the recipient has released or disclosed the software, and to seek relief solely from the party who has improperly used, modified, reproduced, released, performed, displayed, or disclosed Contractor software marked with restrictive legends.

(c) *Rights in derivative computer software or computer software documentation.* The Government shall retain its
